# NYSUT Statement on John King's Appointment as Acting U.S. Secretary of Education

"New York State United Teachers is disappointed in John King's appointment as acting U.S. Secretary of Education. NYSUT has always considered John King an ideologue with whom we disagreed sharply on many issues during his tenure as the state's Education Department commissioner. Just last year, our members delivered a vote of no confidence against him and called for his resignation. NYSUT urges its members to call the White House switchboard at 202-456-1414 — as well as a special White House telephone line dedicated to public comments at 202-456-1111 — to express their displeasure in John King's appointment."

- Deadline for new APPR plan extended to November 17, 2015
- Districts must be negotiating new APPR Plan (we have been)
- Not all the pertinent information and guidance needed to negotiate intelligently has been released
- Many pieces have been "tweaked or changed" since it was signed into law in April
- It still relies very heavily on student performance
- We must follow the "old APPR" plan (which was revised with the new contract) until the new APPR has been agreed to.
- If we are unable to settle by November but have been trying to in good faith we may be granted a hardship waiver. This has to be applied for.
- Expect to be trained in the new APPR even if it has yet to be settled (this is evidence of us trying in good faith to settle).

You take sixteen tests, what do you get Another year older and education in debt Hey College don't you call me 'cause I can't go Cuomo sold my soul to the common core


Next year same mornin', it was test time again grabbed my pens and off to the test I went my teachers they taught me and I knew it plain But when the results came in, I saw what it meant

#### **Hudson Valley Honor Flight**

hat do Valley Central alumni/staff members, Donna Barletta, Donna Boyce and Denise Bromm have in common? No, not the initials "D.B."! They all had the honor and privilege to be the "Guardians" of their Dads on a Hudson Valley Honor Flight. This past spring, Montgomery Elementary's Randy Sutter accompanied his father-in-law. Valley Central's middle school paraprofessional, Michelle Donovan, also was a guardian on an Honor Flight with her Grandfather.

Donna Boyce went with her father,

Nicholas A. Martellotto, on the inaugural flight on June 9, 2012. He was a Sergeant in the Army Air Force. Donna said, "I was blessed that we made it on that flight as the next one (April 2013) was a couple months after he passed away".

Donna Barletta went on the inaugural flight with her father, Jacob (Jack) Barletta. He was a WWII Army Staff Sergeant who was

awarded two Purple Hearts and the Bronze Star. Donna stated that she was grateful to have this experience with her Dad who passed away last year.

Fourth grade M.E.S. teacher, Randy Sutter accompanied his father-in-law, Dr. George Tracy on the May 30th, 2015 Leather-stocking Honor Flight out of Albany. He was a WWII Sgt. in the Army Signal Corp. Randy expressed the same sentiments about the honor flight being one of the most memorable days of his life. He also gets choked up when talking about the events of the day, saying that the people who ran it did an impeccable job and didn't leave out a single detail.

Michelle (Hembury) Donovan went on

the September 2013, flight, out of Stewart, with her grandfather, Edwin Hembury (known as Duke to his family), who was 88 at the time. Her grandfather was a sailor, whose served as a gunner protecting the Merchant Marine Ships in World War II. He was on 7 different ships, 3 of which were attacked and sunk while he was aboard, leaving him floating in the ocean. Michelle said, "My grandfather never talked much about World War II, until I took him to Washington DC with the Honor Flight. He told me so many stories and enjoyed every minute of the trip. My grandfather was also interviewed and

appeared in the movie premier, Hudson Valley Honor Flight: The Generation Bridge, in March, at the Middletown Theater (I highly recommend you seeing the movie, it was wonderful!). My grandfather is getting older, so his memory is starting to go but sometimes he still talks about going on the Honor Flight, and as much as it was memorable for him and he might not remember it. I will remember it forever and

I am so glad I put his application in to go".

Denise Bromm considers herself blessed and honored to have joined her father, retired teacher, Harold James (Jim) Bromm on the April 11, 2015 flight. He was a Lieutenant, Marine Corps Reserve during the Korean War. His best man, John McIntyre who was in the Army during the Korean War, was also on this flight. This was the first flight that included Korean War Veterans and one (terminally ill) Vietnam Veteran. Along with a great flight, beautiful weather and a police escorted tour of the memorials (no sitting in traffic for these 3 busloads of veterans!), we got to enjoy the beauty of the cherry blossoms on this glorious day.

magine being forced to resign from your teaching position — with no guarantee of being rehired — just because you got pregnant. Or not having a designated lunch break during your workday; forced instead to either eat with your students or to cover lunchroom duty. Or imagine this: After earn-

ing your academic degrees and participating in months of teacher training, finding out that your take-home pay is less than the workers at the neighborhood car wash.

Stories like these sound crazy today.

But before widespread teacher unionization, these scenarios were real. In fact, they were just a handful of the many injustices educators faced. Prior to the 1960s, teachers' professional lives were governed by administrators who held abso-

lute power over what was taught, who was hired, who was fired and class sizes.

In his book, <u>Teachers United: The Rise of New York State United Teachers</u>, author Dennis Gaffney details the antics of administrators like Abe Greenberg, an assistant principal at Astoria Junior High in Queens, who spied on teachers with binoculars throughout the day. Among other questionable opinions Greenberg held, he believed that educators should only lecture while standing. Teachers were chastised for sitting during class; Greenberg called it unprofessional.

In a 1996 New York Teacher story detailing the early days of the union, United Federation of Teachers retiree Lou Carrubba, said teachers had to "eat a lot of crow" back then.

"Today's teachers have no idea. I'm telling you, hardly a day went by when we weren't humiliated in one form or another," he said. "There was no real grievance machinery, no protections, no due -process procedures. Besides, if you complained, they'd make your life even more miserable."

Sick days required a doctor's note or

teachers weren't paid. Until 1957, pensions didn't exist and to get one educators had to be 65 or have 35 years of service. And lunch and other breaks were unheard of. "You lined up with your kids in the schoolyard and stayed with them the whole day, even eating with them — not even a bathroom break," remembered Janet Miller, UFT retiree.

Said UFT retiree Alice Marsh of one first-grade class of 48 students she taught, "I had to leave 12 children back because I couldn't get to them when

they were slipping. This was par for the course." A 1952 New York Post article, "The Scandal of Our Schools," reported that one Queens elementary school built for 1,140 students had an enrollment of just under 3,000. And teachers really did earn less than car washers. A January 1955 New York Times editorial, titled "Teach or Wash Cars," asked why anyone would take a teaching position at \$66 a week when washing cars paid \$72.35.

Longtime NYSUT retiree activist Sylvia Matousek, remembers earning \$4,400 as a new teacher in North Syracuse in 1964 — a sum that forced many educators to apply for food stamps. Teachers were also required to inform the district superintendent immediately if they became

pregnant. "The big joke was that you'd call the superintendent at two o'clock in the morning, and say, 'Oh, well, I think I just got pregnant," said Matousek.

Many current NYSUT members are too young to remember the early union struggles, but those struggles paved the way for what educators now consider the status quo. But with the stroke of a lawmaker's pen, or a single U.S. Supreme Court decision, today's "status quo" could become tomorrow's "good old days." Your hard-won rights, your voice at the table, could be lost — unless you remain vigilant.

When you hear the value of collective

bargaining questioned in the faculty room, at the water cooler or after the morning meeting, remember the struggles of those who came before you — the battles teachers waged in the early days to earn the benefits you enjoy today. If today's political climate teaches us anything, it's that nothing is guaranteed. You must be vigilant to ensure your rights are not stripped away.

Don't let complacency return us to the bad old days.

Remember the value of your union.
